#### UNITED NATIONS ACT, No. 45 OF 1968

#### Regulations

The United Nations Regulations No. 02 of 2012 published in *Gazette Extraordinary* No. 1760/40 of May 31, 2012, are hereby amended as follows :-

- (1) by the substitution for regulation 2 thereof, of the following :-

“2. The United Nations Security Council Resolution 1267(1999) and the modifications and strengthening of the Resolution’s sanctions regime by subsequent resolutions including 1526 (2004), 1617 (2005), 1735 (2006), 1822 (2008), 1904 (2009), 1988 (2011), 1989 (2011) and 2253 (2015) and any other subsequent resolution, which set out wide-ranging strategies to combat terrorism and in particular measures to be imposed against the Afghan faction known as the Taliban (which also calls itself the Islamic Emirate of Afghanistan), Islamic State of Iraq and Levant ( ISIL, also known as Da’esh) and Al-Qaida, impose upon member States of the United Nations a series of obligations to apply sanction measures to any natural or legal person, group or entity associated with Taliban, ISIL (Da’esh) or Al-Qaida as designated



by the Sanctions Committee (hereinafter referred to as the “designated person”) and whose name appears on the “Consolidated List” adopted by the Sanctions Committee. The Security Council of the United Nations, acting under Chapter VII of the Charter of the United Nations, on 15th October, 1999, unanimously adopted Resolutions 1267 (1999).” ;

(2) in regulation 17, by the repeal of paragraph (a) of the definition of the expression “Sanctions Committee” and substitution therefore of the following :-

“(a) the committee established pursuant to United Nations Security Council Resolutions 1267 (1999), 1989 (2011) and 2253 (2015), the 1267/1989/2253 ISIL (Da’esh) and Al-Qaida Sanctions Committee which has responsibility in relation to sanctions for Islamic State of Iraq and Levant (ISIL, also known as Da’esh), Al-Qaida and associated individuals, groups, undertakings and entities ; ”.
